Appointment of Adetokunbo Anifalaje to the Greater New Haven Transit District
Ms. Anifalaje said that she had worked for “safe streets” legislation and planning in the city. She added that she is very interested transportation issues and has ideas for improvements.

Appointment of Justin T. Bagnati to the Greater New Haven Transit District.
Mr. Bagnati identified himself as a daily bicycle commuter. He said he is interested in healthy transportation alternatives.
